EXPLANATION OF CONSIDERATION PROCESS

In considering individuals for nomination to the NABPAC Board of Directors, a Nominating Committee consisting of the seven (7) members of the Executive Committee will review applications and interview candidates. During this evaluation, a variety of factors may be weighed, including the following:

Tier One Considerations (in no particular order):

- Tenure in PAC/political affairs profession or comparable time in congressional or state legislative office
- History of innovation and increased PAC receipts during tenure as a PAC professional
- Participation at PACRap luncheons
- Participation at NABPAC webinars
- Participation at annual conferences
- History of recruiting new NABPAC members

Tier Two Considerations (in no particular order):

- Tenure of membership in NABPAC
- Speaking or moderating role at PACRap sessions, webinars, briefings, and conferences
- Ability to commit to attend all fee-based educational offerings in a given year, with certain exceptions for out of town members and those individuals facing personal/family issues
- Ability to help sponsor official NABPAC functions throughout tenure

After telephone or in-person interviews with all individuals who have submitted their names for consideration, the Nominating Committee will meet to discuss candidates and, following a vote of the Committee, forward recommendations to the current Board of Directors. The NABPAC Board then will deliberate on these recommendations and vote to seat final members.

NABPAC Board members are elected to two-year terms, and are entitled to no more than two consecutive terms. After a one-year hiatus, individuals may be considered for Board positions.

We thank you for your interest in Board leadership. Please note that in any given year there may be more candidates than open positions. Serious consideration will be given to all candidates.
